To enter: Bring your original artwork and a signed exhibition agreement (form is on the backside of the prospectus and is found in the PUB Gallery of Art, on the Peninsula College website, and on the Peninsula College PUB Gallery of Art Facebook page) to the PUB Gallery of Art in J building on Tuesday, May 16 from 10:00am-2:00pm, or Wednesday, May 17 from 10:00am-2:00pm. All artwork must be clearly labeled on back with: artist name, email address and/or phone number, title of work, medium, and year created. All 2-D artwork must be ready to hang and framed when appropriate. All work not selected for the show may be picked up from J-7 on Thursday, May 25th from 12-2pm or will be placed in the gallery upon conclusion of the show for retrieval. All artwork selected for the show must be picked up from the PUB Gallery of Art at the conclusion of the show on Thursday, June 15, or Friday, June 16, 2017. Any artwork that needs to be removed before then must have prior approval.
