<u>Verification Worksheet – Independent – 2023-2024</u>

Your FAFSA application was randomly selected by the federal processor for a process called "verification." The law states that before awarding Federal Student Aid we may ask you to confirm the information you (and your spouse, if applicable) reported on your FAFSA. The Financial Aid Office will compare information from your FAFSA with your and your spouse's financial documents. Peninsula College may be required to correct your FAFSA if there are differences between your FAFSA and the documents you submit for verification.

Required Steps and Instructions:

- 1. Complete all sections of this worksheet, including signatures, in blue or black ink. (We cannot accept pencil.) You MUST sign this worksheet. **Electronic signatures are not permitted.**
- 2. Submit this worksheet and other required documents to the Financial Aid Office via regular mail or fax, or via our secure drop box, here. Please do not send information via email; it is not secure. Do not submit this worksheet to the U.S. Department of Education.
- Incomplete worksheets will not be accepted. These documents are required to complete your financial aid file and must be submitted prior to the quarterly deadline in order to be processed before the start of the quarter.
