<u>Verification Worksheet – Independent – 2025-2026</u>

Your FAFSA application was randomly selected by the federal processor for a process called "verification." The law states that before awarding Federal Student Aid we may ask you to confirm the information you (and your spouse, if applicable) reported on your FAFSA. The Financial Aid Office will compare information from your FAFSA with your and your spouse's financial documents. Peninsula College may be required to correct your FAFSA if there are differences between your FAFSA and the documents you submit for verification.

Required Steps and Instructions:

- Complete all sections of this worksheet, including signatures, in blue or black ink. (We cannot accept pencil.) You MUST sign this worksheet. Electronic signatures are not permitted.
- Submit this worksheet and other required documents to the Financial Aid Office via regular mail (if using a notary), or in person (if not using a notary.) Please do not send this completed form via email; the original signed form is required by the Financial Aid Office. Do not submit this worksheet to the U.S. Department of Education.
- Incomplete worksheets will not be accepted. These documents are required to complete your financial aid file and must be submitted prior to the quarterly deadline in order to be processed before the start of the quarter.

Student Tax and Income Information for 2023:

The FUTURE Act of 2019 requires the Department of Education to access the Federal Tax Information (FTI) of FAFSA applicants—and, where applicable, their parents and spouses—through a secure method. Students and parents must provide their consent on the FAFSA for the exchange of FTI; it is now a requirement for receiving federal student aid, even if the student or parent did not file taxes for that year or did not have income.

If the student and/or parent does not provide consent on the FAFSA for the transfer of their information from the IRS, the student will not be eligible for federal student aid until the necessary consent is provided.
