FOR THE 2015-16 ACADEMIC YEAR EMERGENCY GRANT ASSISTANCE WAS PROVIDED TO STUDENTS IN THEIR FINAL QUARTER OF ATTENDANCE, RESULTING IN 100% RETENTION OF THOSE STUDENTS. 44 STUDENTS LOANS WERE PROVIDED FOR BOOKS AND 139 TUITION SCHOLARSHIPS AND GRANTS WERE AWARDED.
