FOR THE 2018-19 ACADEMIC YEAR, 1,059 INDIVIDUAL AWARDS WERE MADE TO STUDENTS, RANGING FROM PUBLIC TRANSIT PASSES AND BOOK PURCHASES TO TRAINING FOR CDL CERTIFICATION AND FULL-RIDE SCHOLARSHIPS.
